# Reducing the threats to pollination

# Dr Denis Anderson

European honeybees, which are the dominant pollinators of food crops, are under threat in Australia from several exotic species.

CSIRO's ground breaking research has raised awareness of the biosecurity threats posed to Australia's pollination services by investigating pests and diseases of honeybees.

Several exotic species pose a significant threat to honeybees in Australia and the whole of the Australian beekeeping industry.

One in every three mouthfuls of food that we consume comes to us through the aid of pollination by honeybees.

CSIRO's research has helped drive a shift in policy and perception which has led to the recognition of honeybees as Australia's key pollinator of over A\$2 billion dollars of agricultural production,

Dr Denis Anderson is recognised as an interna-

tional bee researcher and expert. He, along with his team won the 2007 CSIRO Medal for research achievment

adding to the profitability and viability of key agricultural industries and the communities that depend on them.

On Tuesday 14 August 2012, the Conservation Council ACT Region was at the launch of the combined environment group campaign, Protect the Laws that Protect the Places you Love, at Parliament House.

Under pressure from big business and the mining industry, federal and state governments have announced an aggressive plan to wind back essential environmental protection laws. In the guise of cutting 'green tape' government and industry propose to hand important federal approval powers to the states, and fast track approvals for large developments.

This will remove essential federal protection for our special places and wildlife and accelerate mining and other destructive development in our forests, woodlands and along our coasts.



In response to these threats environmental organisations across the country have come together to launch a national campaign to defend and strengthen our environmental protection laws.

A sincere thank you to those of you who have volunteered to help with the visit of 70 interstate Field Naturalists. You will be contacted soon, if that hasn't been done already.

You should have received several sheets in the mail from our Treasurer Bob Lehman outlining the costs associated with the various activities for our local members. These are to assist in covering the costs of the coaches, CSIRO/Yowani/CIT room hire and the food presented on these occasions. We have chosen private coaches in order to keep the groups together, to enable explanations to take place over the intercom when needed, to help with parking, and to fit our schedule. School bus and peak hour bus needs precluded any other choice.

The Monday evening speakers are Dr Gavin Young on Fossils (Yass) and Dr John La Salle on the Atlas of Living Australia. ## Census of the Vascular Plants, Hornworts, Liverworts and Slime Moulds of the Australian Capital Territory

Version 3.0

#### 8th June 2012

#### Introduction

This Census lists the scientific names of the native and naturalised vascular plants (Pinophyta and Magnoliophyta), hornworts (Anthocerophyta), liverworts (Marchantiophyta) and slime moulds (Myxogastria) known to occur in the Australian Capital Territory, but excluding the Australian Commonwealth Territory of Jervis Bay on the New South Wales south coast. All records are based on herbarium specimens housed in the Australian National Herbarium (CANB). This version of the Census updates version 2.0 (12th December 2008). Future versions of the Census will provide additional coverage of remaining cryptogamic groups including mosses, lichens, algae and fungi.

As with all censuses, this is a work in progress, and changes to the taxa listed can be expected as new collections and data become available. The Census compilers welcome any feedback – please contact them at canbr-info@anbg.gov.au if you have any comments or corrections.
